## PARENT PERMISSION AND WAIVER OF LIABILITY FOR ATHLETE PARTICIPATION IN WRESTLING

By signing below, I give permission for my child, \_\_\_\_\_, to participate in any/all athletics & activities during the 2020-2021 wrestling season with the Wright City Jr Wildcats.

\_\_\_\_\_, \_\_\_\_\_ (Parent and Athlete Initials) I acknowledge that federal and state government officials have declared that there currently exists a public health crisis in our country related to the Coronavirus Disease 2019 ("COVID-19").

\_\_\_\_\_, \_\_\_\_\_ (Parent and Athlete Initials) I confirm that I will not permit my child to participate in the program or activity if, at any time during the program or activity, my child is showing any symptoms of COVID-19 (including but not limited to **fever, dry cough, fatigue, shortness of breath, chills, muscle pains**). Additionally, I confirm that I will not permit my child to participate in the program or activity if, at any time during the program or activity, my child has been in contact with any individual diagnosed with COVID19 or any individual currently waiting for test results confirming the possibility of a COVID-19 diagnosis. I agree that in such situations, my child will be unable to participate in the program or activity until: **(i) 14 calendar days after the symptoms first appeared and my child is no longer showing any symptoms; or (ii) a healthcare provider has confirmed in writing that my child has tested negative for COVID-19 or that my child's symptoms were not due to COVID-19.**

\_\_\_\_\_, \_\_\_\_\_ (Parent and Athlete Initials) I understand that the Wright City Jr Wildcats cannot prevent the possible transmission or contraction of COVID-19 for my child. The undersigned agrees to release, discharge, hold harmless and indemnify the Wright City Jr Wildcats, Wright City Lions Club, USA Wrestling, Amateur Athletic Union (AAU), any club school or organization that holds an event the Wright City Jr Wildcats attend to wrestle, any of their agents, employees, officers, board members, insurers and others acting on the wrestling clubs behalf (the "Releases"), of and from any and all claims, demands, causes of action and/or legal liabilities for injuries to or death of my child occurring during, or resulting from, or participation in the above-mentioned program or activity and related in any way to COVID-19, even if the cause, damages or injuries are alleged to be the fault of, or alleged to be caused by, the negligence or carelessness of the Releases.
